A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, APPROVING THE APPLICATION OF LOWELL COMMUNITY DEVELOPMENT CORPORATION FOR STATEWIDE PARK DEVELOPMENT AND COMMUNITY REVITALIZATION PROGRAM GRANT FUNDS AND STATING INTENTION TO ACCEPT PROJECT AND CONTRACT OBLIGATIONS UPON SUCCESSFUL COMPLETION OF PROJECT AND STATE'S APPROVAL OF THE TRANSFER SHOULD THE GRANT BE AWARDED

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility by the Legislature of the State of California for the administration of the Statewide Park Development and Community Revitalization Grant Program, setting up necessary procedures governing the application; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require the Applicant (Lowell Community Development Corporation (Lowell CDC)) to certify by resolution the approval of the application before submission of said application to the State; and

WHEREAS, successful Applicants will enter into a contract with the State of California to complete the Grant Scope project; and

WHEREAS, the Council intends to accept the project and contract obligations from Lowell CDC upon successful completion of the project and the State's approval of the transfer, should grant be awarded; and

APPROVES THE FILING OF AN APPLICATION BY LOWELL CDC FOR THE PROJECT (DEVELOPMENT OF A PARK IN THE LOWELL NEIGHBORHOOD OF FRESNO); AND

1. Certifies that said Applicant has or will have available, prior to commencement of any work on the project included in this application, the sufficient funds to complete the project; and

2. Certifies that if the project is awarded, the Applicant has or will have sufficient funds to operate and maintain the project; and

3. Certifies that the Applicant has reviewed, understands, and agrees to the General Provisions contained in the contract shown in the Grant Administration Guide; and

Delegates the authority to the Chief Executive Officer of the Lowell Community Development Corporation to conduct all negotiations, sign and submit all documents, including, but not limited to applications, agreements, amendments, and payment requests, which may be necessary for the completion of the Grant Scope; and

5. Agrees to comply with all applicable federal, state, and local laws, ordinances, rules, regulations, and guidelines.

6. Will consider promoting inclusion per Public Resources Code §80001(b)(8 A-G).
