A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO JOIN THE MULTI-CITY/COUNTY AMICUS BRIEF IN SUPPORT OF PLAINTIFFS/RESPONDENTS IN THE DEFERRED ACTION FOR CHILDHOOD ARRIVALS (DACA) CASES CURRENTLY BEFORE THE UNITED STATES SUPREME COURT

WHEREAS, the City of Los Angeles, together with the County of Los Angeles, will be filing a multi-city/county amicus brief in support of the plaintiffs/respondents in the Deferred Action for Childhood Arrivals (DACA) cases currently before the United States Supreme Court; and

WHEREAS, of the 20,000 people working as teachers eligible for DACA, approximately 5,000 are in California; and

WHEREAS, DACA recipients make up 27% of all sales, office, and administration workers nationwide; and

WHEREAS, of all food preparation, serving, and farming workers in the U.S., 18% are DACA recipients; and

WHEREAS, DACA recipients fill 18% of all U.S. construction and production jobs; and

WHEREAS, the City of Fresno has a significant number of active DACA recipients as residents; and

WHEREAS, prior briefs at the circuit court level were joined by jurisdictions representing nearly 50% of all DACA recipients, including New York City, Houston, Atlanta, and Chicago; and
