During periods of high demand, the current 1.5-million gallon finished water reservoir restricts filter backwash operations, impairs operational recovery stemming from unanticipated shutdowns associated to water quality changes, and has limited storage available to support fire flow demands. The new 4.5-MG tank will resolve the current operational deficiencies and will be capable of supporting higher flow conditions when the NESWTF is expanded in the future.


