# **EXECUTIVE SUMMARY**

On December 18, 2014, the City of Fresno adopted the Fresno General Plan. The City desires to review the progress in the first five years of implementation.

## **BACKGROUND**

On December 18, 2014, the City of Fresno adopted the Fresno General Plan which laid out a series of policies to prioritize and govern development of the City. In ten resource area chapters, the document

identifies objectives and policies to plan for orderly growth and development according to the Governor's Office of Policy and Research (OPR) General Plan Guidelines.

The City certified a Master Environmental Impact Report (MEIR) which evaluated the impacts of potential development through the year 2035. The MEIR is currently being updated to reflect the new California Environmental Quality Act (CEQA) Guidelines and provide for streamlined development approvals.

WHEREAS, California Government Code Section 65300 requires cities to adopt a comprehensive, long-term general plan for the physical development of the city and of any land outside its boundaries which bear relation to its planning; and

WHEREAS, on December 18, 2014, the Council of the City of Fresno updated the 2025 Fresno General Plan for the City of Fresno and its Sphere of Influence (SOI) by adopting the Fresno General Plan, by Resolution No. 2014-226, and by Resolution No. 2014-225 certified Master Environmental Impact Report SCH No. 2012111015 (MEIR) which evaluated the potentially significant adverse environmental impacts of

urban development within the City of Fresno's designated urban boundary line and sphere of influence; and

WHEREAS, the objectives, goals and policies of the Fresno General Plan have been implemented since adoption; and

WHEREAS, Chapter 12 of the Fresno General Plan pertaining to implementation calls for the City to reevaluate the General Plan every five years using information from, but not limited to, market demand studies and analysis to determine the City's land use needs; and

WHEREAS, in order to accommodate local conditions and circumstances as well as adapt to changes in the City and environment over time, the City may engage in periodic review of and comprehensive updates to its General Plan; and

WHEREAS, it is in the best interests of the City of Fresno to expand access to housing options across all housing categories and to incentivize infill development and development along the City's BRT corridors; and

WHEREAS, the City Council desires to initiate a comprehensive update of the Fresno General Plan in order to better incentivize development, expand access to housing, and to better accommodate the changed local conditions, circumstances and environmental factors; and

WHEREAS, the City Council desires to initiate the amendment or repeal of any Community, Specific or other plan approved by the City that is necessary to ensure consistency with any future adoption of an update to the Fresno General Plan; and

WHEREAS, a comprehensive update to the Fresno General Plan will constitute a new General Plan; and

WHEREAS, pursuant to Fresno Municipal Code Section 15-4902-B, the City Council has the authority to initiate new plans.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. The Council, pursuant to Fresno Municipal Code Section 15-4902-B, hereby initiates the General Plan Update.
- 2. The Council, pursuant to Fresno Municipal Code Section 15-4902-B, hereby initiates amendments to the following Plans:
  - a. Woodward Park Community Plan;
  - b. Bullard Community Plan (which includes the Pinedale Neighborhood Plan and the Sierra Sky Park Land Use Policy Plan);
  - c. Hoover Community Plan (which includes the El Dorado Park Neighborhood Plan);
    - d. West Area Community Plan;
    - e. Fresno High-Roeding Community Plan;
    - f. McLane Community Plan;
    - g. Downtown Neighborhoods Community Plan;
    - h. Edison Community Plan;
    - i. Roosevelt Community Plan;
    - j. Butler-Willow Specific Plan;
    - k. Fresno-Chandler Downtown Airport Master Plan;
    - I. Fresno Yosemite International Airport Land Use Compatibility Plan;
    - m. Fulton Corridor Specific Plan;

- n. Highway City Neighborhood Plan;
- o. North Avenue Industrial Triangle;
- p. Southwest Fresno Specific Plan;
- q. Tower District Specific Plan;
- r. Yosemite School Area Specific Plan.
- 3. The Council hereby directs staff to prepare a Draft General Plan Update and prepare an environmental assessment consistent with the requirements of the California Environmental Quality Act (CEQA).
- 4. The Council also hereby directs staff to return to Council with an outline and proposed timeline of the process for preparing an update to the Fresno General Plan and for preparing an environmental assessment for the update.
- 5. In preparing a Draft General Plan Update, the Council directs staff to include consideration of an expansion of the Sphere of Influence (SOI), as well as consideration of renegotiation of any existing agreements with the Fresno Irrigation District (FID).

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Council of the City of Fresno as follows:

1. The intent of the City Council in initiating the General Plan update, and the amendment or repeal of Specific, Community or other plans identified above, is to fully evaluate and consider the merits thereof, and the fact of initiation shall not be construed as a determination by the City Council of the final merits of any update, alternative, amendment or repeal or a commitment by the City Council to a definite course of action related to any activity initiated by this Resolution.
