WHEREAS, the City of Fresno acknowledges that building civic engagement experience in youth allows them to become engaged in local government, empowers youth in making a difference, develops a sense of self-efficacy, and builds character, confidence, and competence; and

WHEREAS, the Fresno City Council supports civic youth engagement, allow the City of Fresno Youth Commission to present the award, and hold an awards ceremony at Fresno City Hall and

WHEREAS; the Rising Youth Award will be awarded by the City of Fresno to youth that have excelled in the creation and implementation of their civic project for the purpose of encouraging youth city-wide to become civically engaged; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as

follows:

1. The City Council hereby establishes the City of Fresno Rising Youth Award and authorizes the Fresno Youth Commission to select award recipients, and Councilmember Nelson Esparza or councilmember appointee to oversee the award program as outlined in Exhibit A. Awards shall be presented at a regular meeting of the Council.

Exhibit A

The Fresno Youth Commission shall select up to two award recipients per year based on the criteria below. In its discretion, the Fresno Youth Commission may form a committee, whether standing or ad hoc, to review applications and select award recipients.

Year 1

Recipients of this award will be youth that are 13-21 years of age who have organized and conducted a civic engagement project that has created a significant change in the Fresno community. If successful, the Civic Engagement Committee will open up to other age groups determined by review.

Year 2

Pending successful review of year 1, recipients of this award will be expanded to youth ages 11-13.

- 3. Connect with businesses to post flyers
- 4. Utilize social media to promote award

Application Process

Application deadline will be in February 23rd, Process between March-April, and award in mid-May.

Handing out a plaque to award recipients along with Grizzly tickets and scholarship award of \$250 to each recipient.
