A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, TO APPOINT A GENERAL PLAN  
REVIEW COMMITTEE

WHEREAS, the City of Fresno adopted the Fresno General Plan on December 18, 2014; and

WHEREAS, the Fresno General Plan called for the formation of an implementation committee; and

WHEREAS, the Fresno City Council desires to evaluate the progress of the plan to date.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The City Council of the City of Fresno hereby establishes a General Plan Implementation Review Committee (GPIRC) comprised of 17 members, two appointed by each councilmember and three appointed by the Mayor, to discuss the progress toward implementing the policies of the General Plan and to make recommendations to the Mayor.

2. Appointments should be made no later than December 31, 2019, and the committee will meet a minimum of at least two times per month starting in January 2020 and concluding in June 2020 and then provide a report for the Mayor, City Manager and City Council.

3. The Planning and Development Director will be responsible for arranging and staffing the GPIRC. The GPIRC shall be a standing committee subject to the

Brown Act. All meetings will be open to the public.

4. The Administration shall propose sufficient funding in the Fiscal Year 2020-21 budget for a General Plan Update.
