***P3a. Description:** This 3,360 sf one-story Mid-Century Modern commercial building faces east onto G Street and is constructed of concrete masonry units with a flat roof. The facade has a smooth stucco application to which are attached an eclectic assortment of three dimensional decorative shapes faced with brilliant blue tiles. At each end of the facade are pier buttresses, also clad in blue tile. A decorative metal railing sits on top of the facade parapet. With the exception of the front entrance, there are no piercings... no windows as one would normally expect in a late 1960s commercial building. The front door is centrally located and has a metal screen in a decidedly Craftsman style. The door has a surround of textured glass blocks set within a frame of fired red bricks. The north elevation has no openings, the south elevation has two doors, both of which include a screen in the Craftsman style similar to the front entrance. Organic structural pieces, including a whimsical matched pair of piers forming an entryway and covered porch are complimented by a series of planters which hold queen palms, agave and a windmill palm. River rocks complete the front landscaping and apparently once held water. (For additional descriptive information see the attached 2011 primary form).





This 1968 building with its quirky facade is associated with two major figures in Fresno's cultural and architectural history: artist Stan Bitters and architect Robin Gay McCline. Ridge Electric was founded by Wilbur Ridge in the 1920s as a backyard business at his East Fresno home. Circa 1930s, Ridge Electric began to specialize in the repair of car generators when PGE closed their basement shop which did this work and Ridge hired a few of the PGE employees to work for him. Ridge Electric moved several times before son Clair Ridge took over the business and commissioned a new building at the current location in 1968.

Clair and his wife Marge are fondly remembered as innovative, fun and artistic:

...the Ridges, my parents, and many other young families all belonged to the Fresno Sports Car Club in the mid- to late 50's, when little European sports cars (MG's, Triumphs, etc.) were considered a thrilling new arrival on the American automotive scene. Marge Ridge was wildly chic in her tall, thin, tanned, cool appearance, and her taste in architecture matched that. I remember visiting their beautiful Sunnyside home in maybe 1958, where the kitchen floor of loose pea gravel caught my attention! As the G Street building went up and I noticed its distinctly avant garde appearance, I attributed the courage to build it to Marge Ridge's interesting taste. (Julie Linxwiler, personal communication 28 October 2019).

Clair Ridge attributed the unique architectural installations on the building's facade solely to Stan Bitters with whom he had a working relationship. Ridge had completed some electrical work at Bitters' studio, and when it came time to construct a new building, Clair Ridge invited the artist to do design work on the facade. The Ridges knew architect Robin Gay McCline as he had designed their adobe home in the Sunnyside neighborhood (Clair Ridge, Personal communication 20 November 2019).

BSO Update Continued:

Stanley Cleve Bitters is an American ceramics sculptor whose work was instrumental in shaping the organic modernistic movement of the 1960s. He received his Bachelor of Arts in 1959 from UCLA with a B.A. in Painting, He also attended the Otis College of Art and Design in Los Angeles where he studied under Peter Voulkos who proved to be a major influence. Bitters returned to Fresno and in 1959 went to work in Madera for Hans Sumpf who had perfected emulsified adobe bricks. Bitters created architectural murals, tiles, bird houses, planters and sculptural objects for the company during his 6 year tenure ("Stan Bitters" Wikipedia accessed 28 October 2019). (Incidentally, it was during this period that Bitter's Sumpf tiles were applied to the facade of the Robert Stevens designed Pilibos Building, 1961, located at 830 Van Ness Avenue: the first building from the 1960s to be placed on Fresno's Local Register). In 1969 Bitters served as a Design Consultant for the City of Fresno's Civic Center Mall. One of the many highlights of Bitters' 60 year career has been his insistence on the integration of art and architecture... so common up to the early 20th century but out of favor by architects in the 1960s. His hundreds of commissions have included "architectural installations" whether building facade treatments such as 1235 G Street (and the brilliant work at Duncan Ceramics) or the sculpted bronze doors on Fresno's Saroyan Theatre, or fountains, murals or planters (for additional biographical information see attached 2011 survey forms). (continued)

The architect of record for 1235 G Street was Robin Gay McCline. McCline like Bitters was a Fresno native and was born in 1928. He attended U.C. Berkeley on the G.I. Bill and completed a BS in Architecture in 1951. He worked as a draftsman for David Horn from 1951-1956 and worked briefly in 1957 for Robert Stevens A.I.A. during which time he helped to design the Guarantee Savings Building on Ashlan and Blackstone, including the interior mural depicting the history of money. In 1957 McCline formed a partnership with James A. Oakes. James A. Oakes and Gay McCline, Architectural Associates designed at least 60 residential buildings throughout the San Joaquin Valley and several mostly smaller commercial buildings. The firm won an AIA award in 1962 for the McKinley Medical Center McCline taught architecture at Fresno City College from 1963 to 2002. He was also a part-time art instructor at the FCC and was renowned for his watercolors (Mid-Century Modernism Historic Context September 2008).

The Ridge Electric Motor Company Building was evaluated on a professional survey for the City of Fresno as part of the Fulton Corridor Specific Plan (2011/2014) and was assessed as potentially eligible for listing on the Local Register although at the time is was less than 50 years of age. The building is now 51 years of age. Additionally there is no evidence of alterations to the exterior (other than a lack of water in the water feature) and the integrity of the building to its period of significance of 1968 remains high (FMC 12-1607(a)(1). (It is fair to note that some of the tiles and architectural features need repair, but this is an issue of condition, not integrity.)

The building is associated with two major figures in Fresno's architectural and cultural history: Stan Bitters and Robin Gay McCline. The startling application of deep blue tiles to the facade of the building remains fresh. The facade work is also enhanced by the landscaping and Bitter's clay planters. In fairness, one could suggest that the building is not Robin Gay McCline's best work (see for example his 1971 residence) as it mostly serves as a canvas for the applied ceramic work. The entryway (one assumes McCline's design) is however simple and elegant with a single Craftsman style screen door, with a surround of fired red brick and textured glass blocks, as one might see in earlier Streamline Moderne buildings. The building is the only example of McCline's work to be eligible for the Local Register and only the second example of Bitter's ceramic applications. The Ridge Electric Motor Company Building (1968) thus appears to be eligible to Fresno's Local Register of Historic Resources under Criterion iii as a distinct example of the work of two masters. This one-story Mid-Century Modern building features a striking decorative program of applied geometric shapes, made of glazed ceramics. Located on the west side of G Street between Fresno and Merced Streets, the building displays a rectangular plan and flat roof, raised along the facade elevation by a plain parapet wall. The exterior walls, sheathed in smooth, light stucco, provide a contrast for the applied ceramic ornament. Each piece varies in profile and is detailed with scoring. The ceramics display variegated shades of electric blue throughout. This expressionistic design extends to the landscape fronting the building, which includes a series of stucco-clad sculptural pieces along the walkway. Similar sculptural elements set off a water feature and planter box. With no major alterations, the property is in good condition and retains a good level of integrity. Glass entrance doors are recessed within the facade wall and accessed via the walkway and a curved, graduated ramp. Alterations appear limited to the draining of the original water element. The building retains a good level of integrity and continues to convey its period of significance.



*B10. Significance (continued from page 2):

The Los Angeles Times praised the design, calling it "one of the most beautifully decorated industrial buildings in the country." (Los Angeles Times, 20 October 1968.) This project mirrors Bitters' work on 1235 G Street, with the juxtapositioning of a plain, stucco-clad façade and boldly colored geometric pieces of glazed ceramics. His many projects in Fresno include two water features/sculptures in the Fulton Mall, the monumental bronze-relief doors of the M Street entrance to the Convention Center theater, and work on the Fresno Civic Center Mall, for which he served as a design consultant to the City of Fresno in the late 1960s. Recently, Bitters' 1962 work "Birdhouses" was selected for inclusion in the Getty's Pacific Standard Time exhibitions, celebrating post-1945 art in Southern California. "Birdhouses" appeared as part of the exhibit "Golden State of Craft: California 1960 to 1985" at the Craft and Folk Art Museum in Los Angeles.

Throughout the years, Bitters has remained an active force in Fresno's community of artists. In support of a 2004 initiative to incorporate art in new buildings and civic spaces, Bitters' projects were highlighted as successful examples of how to marry art and architecture. Recently, he participated in the events marking the Fulton Mall's 40th anniversary, contributing pieces to an exhibit of traditional and modern sculpture on the mall itself and curating an exhibit on local Fresno artists. Entitled the "Great Eight," the exhibit featured works by Bitters and fellow Fresno artists Frank Arnold, Jane Whitehurst, Mark Rodriguez, Garrett Masterson, Bill Minschew, Robert Ogata, and Maxine Olson.

The architect of record was Robert Gay McCline, a noted Mid-Century Modern architect with many Fresno commissions to his name.
