CONSOLIDATED PLAN & ANNUAL ACTION PLAN

The Consolidated Plan:

- Identifies and prioritizes community development and housing needs
- Develops a 5-year strategy to target federal grant funds to areas with greatest needs

The Annual Action Plan:

- Serves as funding application for the following programs:
 - Community Development Block Grant (CDBG)
 - Home Investment Partnerships Act (HOME)
 - Emergency Solutions Grant (ESG)
 - Housing Opportunities for Persons with AIDS (HOPWA)



STRATEGIC PRIORITIES

- 1. Provide assistance for the homeless and those at risk of becoming homeless through safe low-barrier shelter options, housing first collaborations, and associated supportive services.
- 2. Improve access to affordable housing for low-income and special needs households by partnering with interested developers to increase development of lowincome and affordable housing in high opportunity areas, and by promoting the preservation and rehabilitation of existing affordable housing units.

STRATEGIC PRIORITIES (cont'd)

- 3. Promote quality of life and neighborhood revitalization through improvements to current public infrastructure and facilities, and by closing gaps in areas with aging, lower quality, or nonexistent public infrastructure and facilities.
- 4. Provide services to low-income and special needs households that develop human capital and improve quality of life.

STRATEGIC PRIORITIES (cont'd)

- 5. Provide services to residents and housing providers to advance fair housing.
- Plan and administer funding for community development, housing, and homelessness activities with improved transparency, increased community involvement, and full compliance with federal regulations.



AFFIRMATIVELY FURTHERING FAIR HOUSING

ANALYSIS OF IMPEDIMENTS TO FAIR HOUSING CHOICE

- Analysis of the local fair housing landscape
- Four specific fair housing issues:
 - Integration and segregation
 - Areas of poverty
 - Access to opportunity
 - Housing need
- Fair housing priorities and goals

POPULATION BY RACE AND ETHNICITY



IMPEDIMENTS TO FAIR HOUSING CHOICE

- 1. Lack of safety net programs for renters facilitates housing instability among protected classes
- 2. Insufficient employment supports leave residents of color with lower incomes and limited housing choices
- Continued need for neighborhood infrastructure development and expanded access to opportunity in areas of concentrated poverty
- 4. Housing options for some protected classes are limited by poor housing conditions

IMPEDIMENTS TO FAIR HOUSING CHOICE (cont'd)

- 5. Racial disparities exist in access to homeownership
- Publicly supported housing options are concentrated outside of areas of opportunity
- Many communications and marketing efforts regarding fair housing are not effectively targeted to protected classes and non-English speakers
- 8. NIMBYism and prejudice reduces housing choice for protected classes
- Continued need for Fair Housing education and enforcement
