A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, CALLING SPECIAL MAILED-BALLOT ELECTION

Community Facilities District No. 17

WHEREAS, on April 23, 2020, the Council of the City of Fresno (Council) adopted Council Resolution No. 2020-083 with the intention to establish the Community Facilities District No. 17 Sewer Lift-Station Maintenance District (CFD No. 17) and to authorize the levy of special taxes; and

WHEREAS, Council Resolution No. 2020-083 identified the Services to be provided by CFD No. 17 and provided an estimate of the cost of providing those Services; and

WHEREAS; Council Resolution No. 2020-083 contemplated imposing a special tax upon those properties within CFD No. 17 receiving said Services; and

WHEREAS, a written report has been filed with the City Clerk of the City of Fresno (City Clerk) that describes the proposed Rate and Method of Apportionment of the Special Tax among the parcels of real property proposed to be included in the CFD No. 17 in sufficient detail to allow all interested parties to estimate the maximum amount each property owner must pay; and

WHEREAS, the levy of said proposed special tax shall be subject to the approval of the qualified electors of the territory proposed to be included in CFD No. 17 at a special election; and

WHEREAS, the Public Works Director has filed a Certificate (Certificate) in these proceedings providing that fewer than twelve registered voters reside within the boundaries of the territory proposed to be included in CFD No. 17.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. The levy of a special tax proposed in Council Resolution No. 2020-083 shall be submitted to the voters pursuant to the City of Fresno Special Tax Financing Law, Chapter 8, Division 1, Article 3 of the Fresno Municipal Code, (City Law).
- 2. The setting of the appropriations limit shall be submitted to the voters pursuant to City Law.
- 3. The two ballot items described above shall be combined into a single ballot measure pursuant to City Law. The ballot language shall be as shown on the three ballot forms attached as Exhibit A, each of which is hereby approved. This Council accepts the Certificate of the Public Works Director filed in these proceedings and, based on the Certificate, finds that fewer than twelve registered voters reside within the boundaries of the territory proposed to be included in CFD No. 17. Accordingly, under City Law the voters in this election shall be landowners owning land within the territory proposed to be included in CFD No. 17.
- 4. The Council further finds that the landowners of record owning property within the proposed boundaries of CFD No. 17 are those set forth in the attachment to the Certificate of the Public Works Director and that the attachment correctly sets forth how much property is owned by each landowner and the number of votes to which each is entitled.

- 5. This Council approves the three forms, attached hereto as Exhibit B, entitled Waiver and Consent Shortening Time Periods and Waving Various Requirements for Conducting Mailed-Ballot Election in CFD No. 17, City of Fresno, County of Fresno, State of California. This Council finds that the rights, procedures, and time periods therein waived are solely for the protection of the voters; may be waived, by unanimous consent, under City Law; and that the waiver constitutes a full and knowing waiver by any voter who has executed the form of these rights, procedures, and time periods.
- 6. Accordingly, this Council calls the special election described herein and sets May 21, 2020 as Election Day. Pursuant to City Law, the election shall be conducted by mailed ballot.
- 7. The City Clerk or designee is directed to mail or deliver the ballots, in the form of Exhibit A attached hereto, to the landowners shown on the attachment to the Certificate of the Public Works Director. The City Clerk or designee shall fill in the names of the landowners and the number of votes to be cast in each ballot, according to the Certificate of the Public Works Director, before delivery or mailing.
- 8. The City Clerk or designee shall accept personal or mail delivery of the ballots at any time up to the time of the hearing on Thursday, May 21, 2020, at 10:00 a.m. Upon receipt of all eligible ballots, however, the City Clerk shall immediately close the election and declare the results to the City Council.
