WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires all jurisdictions that receive federal entitlement funds to prepare a five-year Consolidated Plan, which identifies how the jurisdiction will address housing and community development needs with Community Development Block Grant (CDBG), Home Investment Partnerships Program (HOME), HEARTH Emergency Solutions Grant (HESG), and the Housing Opportunities for Persons with AIDS (HOPWA) funds; and

WHEREAS, HUD requires jurisdictions receiving entitlement funds to submit certification of affirmatively furthering fair housing by completing an Analysis of Impediments to Fair Housing Choice which evaluates barriers to fair housing choice and presents strategies and plans to overcome identified impediments; and

WHEREAS, the City has undergone a comprehensive needs assessment, stakeholder consultation, and citizen participation process; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. The above recitals are true and correct and incorporated herein.
- 2. The Council of the City of Fresno, California, adopts the 2020-2024 Consolidated Plan Including Citizen Participation Plan, the 2020-2021 Annual Action Plan, the Analysis of Impediments to Fair Housing Choice, and approves submission of the 2020-2024 Consolidated Plan Including Citizen Participation Plan, the 2020-2021 Annual Action Plan and the Analysis of Impediments to Fair Housing Choice to HUD incorporating citizen comments made during the public hearing.
- 3. The City Manager is authorized to sign all certifications, applications, instruments, funding agreements, and the like necessary in pursuit hereof, subject to prior approval as to form by the City Attorney.

4. This Resolution shall become effective upon its adoption.
