Councilmember Esparza requested clarification on the housing grant and agreed to the equal distribution amongst the Council districts.

Councilmember Bredefeld stated he would like the economy to reopen to

allow members of the community to go back to work rather than handing them a check.

He stated the Mayor's goal was to have 80% of the CARES Act money remain unallocated and invest 20% to provide direct relief to residents impacted by COVID-19 and to allow City of Fresno to reopen and that we are currently \$5 million under the mark.




