


Overall Sentiment



Councilmen Bredefeld, this is dangerous.



Councilmembers, today you have an opportunity to fulfill you obligation to adhere to and uphold the inalienable rights of Fresnan's to work pursuant to the California Constitution at Article 1 ("Declaration of Rights"), Section 1 ("Inalienable Rights"), which states, "All people are by nature free and independent and have inalienable rights. Among these are enjoying and defending life and liberty, acquiring, possessing, and protecting property, and pursuing and obtaining safety, happiness, and privacy." California courts have held that work is "property" within Article 1, Section 1. Specifically, in Billings v. Hall (1857), the court stated. "The right of acquiring, possessing, and protecting property is one of the primary objects of government, is guaranteed by the Constitution, and cannot be impaired by the Legislature." Pipkin v. Board of Supervisors (1978) stated, "The right to continued permanent employment is so important and so substantially affects the individual that it is a fundamental right." New Method Laundry CO. v. MacCann (1916) stated, "The right of a citizen to pursue any calling, business or profession he may choose is a property right, to be guarded by equity as jealously as any other form of property." Finally, Hofberg v. County of Los Angeles Civil Services Com., stated, "Although public employment is not a constitutional right, one cannot properly be barred from public employment for arbitrary, unreasonable and capricious reasons." Obviously, the inalienable right to acquire property under Article 1, Section 1, is rendered moot wherein the City Council completely strips its citizens of their ability to work. Inalienable rights are not given to Fresnan's from the city council...they are given by birth. As such, the City Council has no right to take them away. Moreover, the Fresno City Charter, at Section 200 ("General Powers"), provides that the City may not have laws which violate the California Constitution as it clearly states, "The City shall have the power to make and enforce all laws and regulations in respect to municipal affairs, subject only to such restrictions and limitations as may be provided in this Charter and in the Constitution of the State of California.." The Council also needs to bear in mind that there is both legislative effort to terminate Governor Gavin Newsom's Executive Order N-33-20 dated 3/19/2020 ("order") pursuant to California Government Code §8629 and a multitude of lawsuits concerning violation of numerous violations of other fundamental rights under the US Constitution and the California Constitution. Finally, the Order is clearly an overreach of the California Dept. of Public Health Director's regulatory authority as there is no authority under her quarantine powers to force healthy people (and/or business owners) to stay home and should be relied upon by the City.
