Update the Greenhouse Gas Reduction Plan

Amend the Mobility and Transportation Element of the General Plan to align with new Vehicle Miles Traveled legislation

- •Add policy affirming VMT as new CEQA metric
- •Minor revisions to clarify LOS use as planning tool



Greenhouse Gas Reduction Plan Update

New GHG Reduction Targets through 2035 Identifies state and local measures to achieve targets

State measures include vehicle regulations, energy portfolio, building codes, and refrigerant rules.

Local measures include trip reduction, commercial energy reductions, water conservation, and waste diversion.



Plan Amendment

- Add one new policy affirming that Vehicle Miles Traveled will be the new transportation metric under CEQA:
 - Use VMT Analysis for CEQA. Use Vehicle Miles Traveled (VMT) as the criteria for evaluating transportation impacts under the California Environmental Quality Act (CEQA), pursuant to Senate Bill 743. Level of Service (LOS) may still be used for planning purposes and implementation of Capital Improvement Projects, however VMT shall be used for determining mitigation under CEQA beginning in July of 2020.
- Remove references to using the old metric, Level of Service, for mitigation

Findings of Fact Statement of Overriding Considerations

Requires that one of the following findings be made if EIR identifies significant environmental impacts:

- Changes have been required which avoid or lessen the significant environmental effect;
- Another agency has required such changes; or
- 3. Specific economic, legal, social, technological or other considerations make infeasible the mitigation measures or project alternatives identified in the FEIR.





EIR Process

Notice of Preparation

- 30-day public comment period May 16 Jun 17, 2019
- Scoping Meeting-May 21, 2019
- · Mailed to stakeholders, agencies
- Noticed in Fresno Bee, Vida en el Valle
- Posted on website, City Hall bulletins
- Posted at City and County Clerks

Notice of Availability

- Release the Draft Program EIR
- 45-day public comment period, from March 6, 2020 to April 20, 2020
- Extended 15 days due to COVID, to May 5, 2020
- Same outreach as for Notice of Preparation

Response to Comments

- Provide to commenters 10 days prior to final EIR Certification, scheduled for August 20, 2020
- Released on July 21, 2020, 30 days prior to EIR Certification

Project presented to all Council District Project Review and Specific Plan Design Review Committees



Staff Recommendation

- 1. REVIEW AND CONSIDER Final Program Environmental Impact Report (Draft PEIR SCH No. 2019050005 and Response to Comments Document), apply the Council's independent judgment and analyses to the review, and then adopt the resolution certifying the FPEIR including the GHG Reduction Plan set forth in Appendix G of the FPEIR, as having been completed in compliance with the California Environmental Quality Act (CEQA), based on the Planning Commission's recommendations on the proposed Final Program EIR and comments thereon.
 - ADOPT an appropriate Mitigation Monitoring and Reporting Program (MMRP) as required by Public Resources Code Section 21081.6 and CEQA Guidelines Section 15097;
 - a. FIND that based upon testimony presented by staff, there are significant, unavoidable, environmental impacts which have not been mitigated to a level below significant. Therefore, the City Council should adopt the findings of fact and adopt an appropriate statement of overriding considerations pursuant to Public Resources Code Section 21081 and CEQA Guidelines Sections 15091 and 15093; and



Staff Recommendation (cont)

- **c. ADOPT the Greenhouse Gas Reduction Plan Update** set forth in Appendix G, pursuant to CEQA Guidelines Section 15183.5(b).
- 2. APPROVE Plan Amendment Application No P19-04226 which requests authorization to amend the text of the Fresno General Plan Mobility and Transportation Element to add a Vehicle Miles Traveled policy consistent with California Senate Bill (SB) 743 and to revise policies and text relating to Level of Service (LOS) metrics to update applicability.
