- SUBJECT: TECHNICAL CORRECTION TO THE 11<sup>th</sup> AMENDMENT TO THE ANNUAL APPROPRIATIONS RESOLUTION NO. 2020-159

It has come to the attention of the Budget Office that a technical correction is necessary to the 11<sup>th</sup> Amendment to the Annual Appropriations Resolution (AAR) No. 2020-159. The original 11<sup>th</sup> Amendment to the AAR reflected \$7,069,200 of Cares Act Funds to be used towards funding food distribution programs. However, it was discovered after Council's approval of the 11<sup>th</sup> Amendment on Monday, August 17<sup>th</sup> that the total amount should have been \$4,512,600. It was discovered that the original Amendment and Staff Report included an overstated funding allotment for one of the lead applicants.

I am requesting that this memo and the attached corrected 11<sup>th</sup> Amendment to the AAR No. 2020-159 be included in the public record.
