



Overall Sentiment



Overall Sentiment







Council President Arias and Council Members, I'm the Executive Director of the Chinatown Fresno Foundation. Our mixed-use neighborhood is included in the Good Neighbor District.

First, we ask that we be actively involved in these discussions since we have such a big stake in the outcome, particularly referring to the Good Neighbor District and the Collaborative Security Plan. We ask that trained professionals be involved for treating mental health and drug-related issues and that the dignity of individuals without housing be respected.

We are concerned that barriers proposed for the Santa Clara area meant to exclude drug dealing will only move that activity into Chinatown.

We are concerned that the proposed transportation services will pick up people who are without housing from across the city and bring them to the Chinatown area. We are NOT in favor of that. That kind of thinking is why there are so many homeless people in Chinatown in the first place - they've been uprooted (or have migrated) from their home neighborhoods in order to receive services that are only offered in one place. We would much prefer that services be offered throughout the city for service to people throughout the city as previous recent plans have recommended.

We look forward to ongoing discussion and workable solutions for this challenging issue, particularly layered on top of the pandemic.

Dear council,

This week, I was out giving water to our homeless along Blackstone and a couple of them brought up some concerns due to COVID-19 restrictions.

I do want to emphasize and thank you again for following and supporting state mandates. I feel safer in Fresno than any of the surrounding counties and communities. I worry greatly about my family and friends in DInuba and Reedley. Because of Fresno following state mandated business restrictions and requiring masks in stores, Fresno is the only city where I do business/shop, because I know people will be wearing masks where I go.

I do want to point out a need among the homeless. Because of the restrictions, they cannot go into fast food restaurants and other businesses to use the restrooms. One sweet woman I know, who shelters near Lafayette Park near Blackstone and Princeton, told me that the restrooms were closed due to some issue, maintenance or otherwise, and she is distressed because they have nowhere to do and do not want to be unsanitary. I am requesting that the council direct staff to look into public bathroom options, not only for this issue, but for ongoing needs.

I also want to lend my support for the item regarding zoning changes to accommodate housing facilities developed from old motels and hotels. I ask that this be passed and that all districts be open to this change of zoning and efforts that ensue and ask these developments be done throughout the city. I'm supportive of the housing developments that may go in my district 7 and to the ease of social services access. Thank you.
