BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment):

The proposed project will deploy Adaptive Signal Control Technology (ASCT) along the downtown BRT corridors, including Stanislaus Street, N Street, P Street, and segments of Van Ness Avenue and Fresno Street, totaling 22 traffic signals. The project will deploy the latest ASCT technology and will install a new camera detection system to 5 traffic signals which do not currently have detection along Van Ness Avenue. This project will demonstrate the functionality, longevity, reliability, and cost effectiveness of the new camera vehicle detection system which includes ground zone detection, and cameras added at the traffic signals. The ITS Project will be the first to incorporate ASCT and Transit Signal Priority at 13 of the traffic signals along corridors and will reduce congestion in the heart of Downtown Fresno.


