WHEREAS, the City and the Consultant desire to extend the Agreement to June 30, 2020, to complete Project; and

WHEREAS, with entry into this Amendment, the Consultant agrees it has no claim, demand, or dispute against the City.

## **AGREEMENT**

NOW, THEREFORE, the parties agree that the aforesaid Agreement be amended as follows:

- 1. The recitals to this Amendment are incorporated and made a part of this Amendment.
  - 2. The Agreement is extended to June 30, 2020.
- 3. Except as otherwise provided herein, the Agreement entered into by the City and the Consultant on May 2, 2016, and the first amendment executed on May 15, 2017, the second amendment executed on October 31, 2017, the third amendment executed on March 15, 2018, and the fourth amendment executed on November 15, 2018, remain in full force and effect.
