- 1. The recitals to this Amendment are incorporated and made a part of this Amendment.
 - 2. The Agreement is extended to September 30, 2019.
- 3. Except as otherwise provided herein, the Agreement entered into by the City and the Consultant on May 2, 2016, and the first amendment executed on May 15, 2017, the second amendment executed on October 31, 2017, and the third amendment executed on March 15, 2018, remain in full force and effect.
