NOW, THEREFORE, in consideration of the above recitals, which recitals are contractual in nature, the mutual promises herein conditioned, and for other good and valuable consideration hereby acknowledge, the parties agree that the aforesaid Agreement be amended as follows:

1. The recitals to this Amendment are incorporated and made a part of this Amendment.

2. The Agreement is extended to August 31, 2018.

3. Except as otherwise provided herein, the Agreement entered into by the City and the Consultant on May 2, 2016, the first amendment entered into by the City and the Consultant on May 15, 2017, and the second amendment entered into by the City and the Consultant on October 31, 2017, remains in full force and effect.
