SECOND AMENDMENT TO AGREEMENT

 - The Agreement is extended to March 31, 2018.
- 3. Except as otherwise provided herein, the Agreement entered into by the City and the Consultant on May 2, 2016, and the first amendment entered into by the City and the Consultant on May 15, 2017, remains in full force and effect.
