

SECOND AMENDMENT TO AGREEMENT

THIS SECOND AMENDMENT TO AGREEMENT (Amendment) made and entered into effect the 31 day of October 2017, between the CITY OF FRESNO, a California municipal corporation (City), and LIVE OAK ASSOCIATES, INC., a California corporation (Consultant).

RECITALS

WHEREAS, the City and the Consultant entered into an agreement on May 2, 2016, (Agreement) to provide professional Biological Resources Monitoring services for Friant Kern Canal Pipeline (Project); and

WHEREAS, the City and the Consultant amended the Agreement on May 15, 2017, to increase compensation for services by \$191,000 and extend the Agreement to October 31, 2017 to complete Project; and

WHEREAS, the City and the Consultant desire to extend the Agreement to March 31, 2018, to complete Project; and

WHEREAS, with entry into this Amendment, the Consultant agrees it has no claim, demand, or dispute against the City.

AGREEMENT


NOW, THEREFORE, in consideration of the above recitals, which recitals are contractual in nature, the mutual promises herein conditioned, and for other good and valuable consideration hereby acknowledge, the parties agree that the aforesaid Agreement be amended as follows:

1. The recitals to this Amendment are incorporated and made a part of this Amendment.
2. The Agreement is extended to March 31, 2018.
3. Except as otherwise provided herein, the Agreement entered into by the City and the Consultant on May 2, 2016, and the first amendment entered into by the City and the Consultant on May 15, 2017, remains in full force and effect.


