WHEREAS, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136, directed HUD to allocate additional entitlement funds to prevent, prepare for, and respond to the coronavirus (COVID-19); and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) allocated an additional Emergency Solutions Grant (ESG-CV2) award to the City of Fresno in the amount of \$8,845,443 to prevent, prepare for, and respond to the coronavirus (COVID-19); and

WHEREAS, the City has prepared Substantial Amendment 2019-05 to the FY 1 of 3
