

## **FIRST AMENDMENT TO AGREEMENT**

THIS FIRST AMENDMENT TO AGREEMENT (Amendment) made and entered into effect the 1st day of October 2020, between the CITY OF FRESNO, a California municipal corporation (City), and **Fresno County Economic Opportunities Commission**, a California corporation (Consultant).

### RECITALS

WHEREAS, the City and the Consultant entered into an agreement on February 1, 2020 (Agreement), to provide professional **Homeless Employment Services** for the Homeless Emergency Aid Program (Project); and

WHEREAS, the City and the Consultant desire to modify the Agreement;

WHEREAS, the parties have negotiated a revised Scope of Services and Budget with a reduction in tasks and related reduction of the total fee for Consultant's compensation for services related to the Project; and

WHEREAS, with entry into this Amendment, the Consultant agrees it has no claim, demand, or dispute against the City.

### AGREEMENT

NOW, THEREFORE, the parties agree that the aforesaid Agreement be amended as follows:

1. The recitals to this Amendment are incorporated and made a part of this Amendment.
2. The Agreement is effective date is modified to October 1, 2020.
3. The Consultant's scope of work is modified as specified in **Exhibit A**.
4. The total compensation for this work for this Agreement is reduced to \$76,122.
5. Except as otherwise provided herein, the Agreement remains in full force and effect until June 30, 2021.
