



Staff Recommendation

- CONSIDER Environmental Assessment No. P19-04594, dated August 5, 2020, a determination that the proposed project is exempt from the California Environmental Quality Act (CEQA) through a Class 32 Categorical Exemption; and,
- DENY the appeal and UPHOLD the action of the Planning Commission, and Planning Director, to deny Conditional Use Permit Application No. P19-04594 requesting to establish the Type 20 offsale beer & wine alcohol sales license.
 - Should the City Council grant approval of the ABC license, the following shall be required:
 - 1. Make exception to location restrictions as outlined in the staff report
 - 2. Amend CUP findings a, b, c, d, & e
 - 3. Adopt Environmental Finding Section 15332/Class 32 Categorical Exemption
