Good Afternoon Respected Council President and Members,

I am writing this email to oppose the issuing of liquor license application P19-04594 at 6940 W. Barstow Avenue, CA 93723.

Council should adhere with City Official and Planning Commission decisions. According to the State Census Tract, this area is allowed to have seven off-sale liquor licenses, but currently there are eight active (I have attached an Active Liquor License document for your review), plus one approved (Shaw and Hayes). This area is over saturated, and there is no need for more liquor licenses to be approved. We were against the gas station since we have seven gas stations within a two-mile radius/ within a five-minute drive. The same developer is building a similar store on Shaw and Hayes Avenue, we have hard time understanding why we need another one at the Barstow corner. Also, it is my understanding the same operator previously owned the Johnny Quick on 99/Golden State where they aggressively advertised cheap beer on their store front and various banners throughout the property. A current example of this aggressive advertising for cheap beer can be observed at the newly built Valero on Herndon/Riverside location, which is next Rio Vista Middle School. As an educator I view this as problematic, this not the message we want to send to our youth. There is a Pre-School being built right next to this gas station on Barstow, how does one justify alcoholic sales next door? The issuance of Liquor Licenses has been an ongoing issue with the City of Fresno as we have more active than we should, why is one being considered near this neighborhood?

The Barstow intersection is very dangerous (on two occasions my family members were involved in accidents at this very corner), as the NW corner property blocks the driver's view for the travelers driving Eastbound on Barstow Ave. Please check the accident record report. Obviously with alcoholic sales at the corner we are asking for MORE danger. With the new Central Unified High School opening next year on Grantland and Ashlan, I can only imagine a much busier Grantland Avenue. This will make this intersection even more dangerous. I make several U-Turns daily to get to my house with my one-year-old at this particular intersection. T the very least the city should install a traffic light before approving any developments in this area.

As per the old and new amendments to the City of Fresno Ordinance 15-2706, this liquor license should not be approved.
