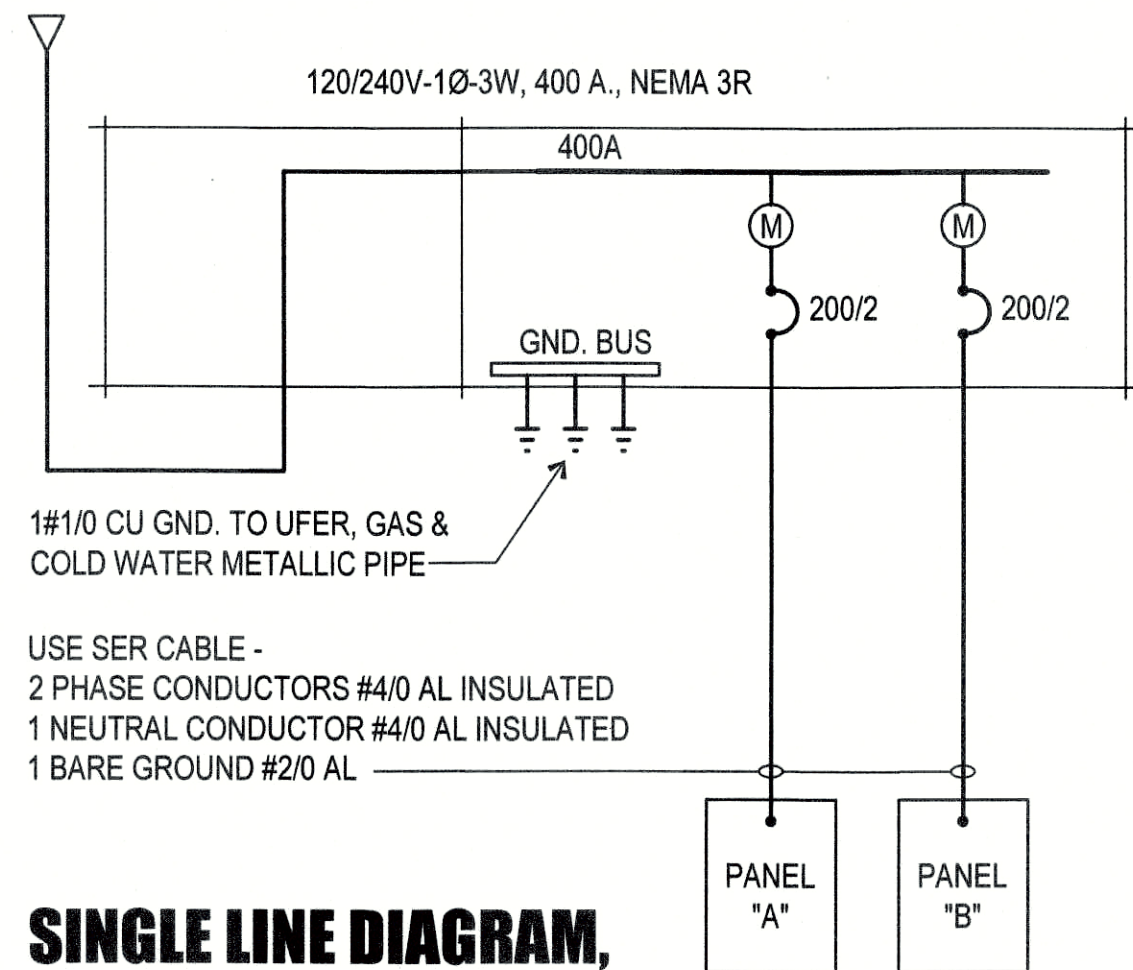

Floor Plan



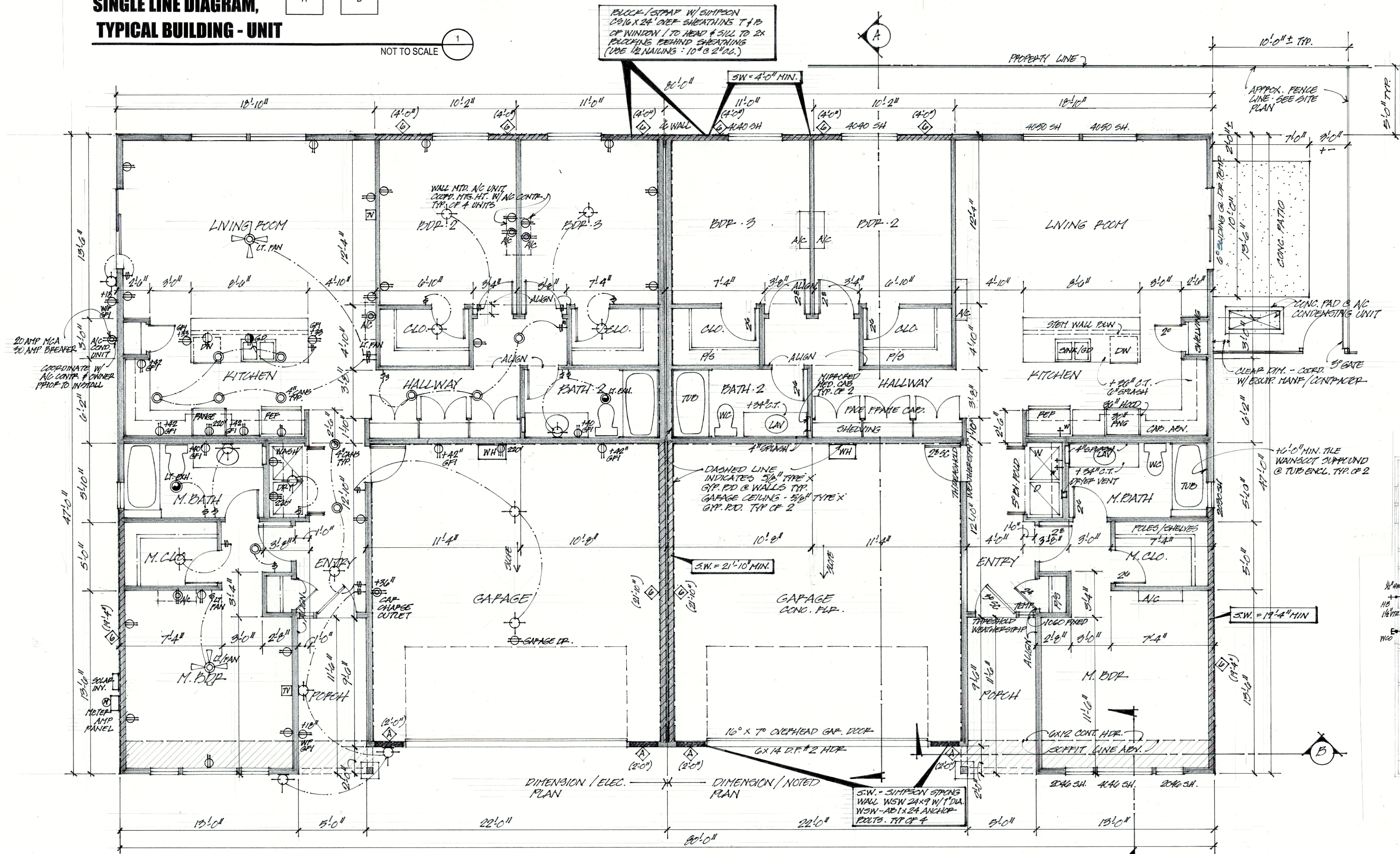
SINGLE LINE DIAGRAM,

ELECTRICAL PLAN

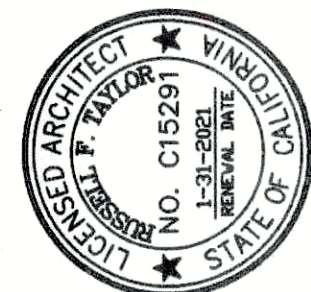
