





We don't have a sample letter available. The meeting is conducted completely by the applicant. I've linked the previsions below of what's required [1]. I can provide the address list however. The regulations require notification of the neighborhood meeting be sent to property owners within 500 feet, however we recommend sending to 1000 ft because later I will have to send my own notice of intent to take action to property owners within 1,000 feet. This could avoid someone protesting later because they received the Notice of Intent but are upset they weren't notified of the neighborhood meeting because they were farther than 500 feet. I can provide both sets of addresses and you can decide how to proceed.

I'll need a report after that includes a summary of what occurred, a sign in sheet of who attended, and a postmarked copy of what was sent. I'll keep drafting my approval documents in the meantime but I'll require those documents before I send my notice of intent to take action or submit my documents to management for an approval.
