The elevated bid amounts received on this project are reflective of the current state of the economy due to the pandemic and in-line with similar capital projects that have undergone competitive bidding and whose bids have opened since the start of the COVID-19 pandemic. The recently bids are consistently coming in higher than engineer's estimate due to the uncertainty associated with COVID 19.

<u>BACKGROUND OF PROJECT</u> (To be completed by Evaluating Department/Division. Explain need for project/equipment):

This Downtown Fresno Courthouse Park Interconnectivity Project was initiated in FY19 when the project was budgeted using ATP revenue. The design commenced following Council approval; preliminary engineering design and project management took approximately two and a half years.

The scope of the project includes the intersections of Fresno Street and L Street and Tulare Street and L street to both receive the reconstruction of several accessible ramps, the expansion of sidewalk at the intersection of Fresno street and L Street, traffic signal installation at both intersections, an exclusive bus transit through Fresno Street and L Street, and signing and striping that will safely guide all pedestrian, vehicle, and transit transportation. Right of way was not needed with the construction of
