A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, NAMING THE "PAUL 'CAP' CAPRIOGLIO COMMUNITY CENTER"

WHEREAS, Councilmember Paul Edward Caprioglio first served as the District 4 representative in 2008, filling a temporary vacancy, in addition to serving two years on the City of Fresno Planning Commission, making it a total of eleven years of public service; and

WHEREAS, he was sworn into office for his first full term as Councilmember for District 4 on January 10, 2013, and served as Council President in 2006 and 2019; and WHEREAS, he is a lifelong resident of District 4; and

WHEREAS, a goal during Councilmember Caprioglio's tenure has been to bring District 4 its own multigenerational community center and community center to the El Dorado neighborhood; and

WHEREAS, there is no other community center in District 4; and

WHEREAS, the community center is intended to serve a diverse population within District 4, including all ages and backgrounds, and will serve as a lasting legacy of Councilmember Caprioglio's passion and dedication to the City of Fresno and the residents of District 4; and

WHEREAS, the City Council finds this action is necessary and appropriate in light of Councilmember Caprioglio's contributions.

- 1. The District 4 community center located at 5191 North 6<sup>th</sup> Street, Fresno, California 93710 shall hereafter be named the "Paul "Cap" Caprioglio Community Center."
- 2. Upon completion of the Multigenerational Center at CW Large Park in Council District 4, it will become the "Paul 'Cap' Caprioglio Multigenerational Center" and the community center on 6<sup>th</sup> Street will no longer hold that name.
- 3. This Resolution is adopted in accordance with Section 8 of Administrative Order-6-2.
- 4. The provisions of Resolution No. 2020-272 shall be waived with respect to this Resolution, as the Historic Preservation Commission is not yet prepared to review such requests.
