A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO NAME THE SOUTHEAST FRESNO POLICE SUBSTATION THE "OFFICER PHIA VANG POLICE STATION"

WHEREAS, Phia Vang was born August 6, 1970, in Ban Phakke, Mouang Phoun, Vanvieng Province in the country of Laos; and

WHEREAS, in 1982, Phia, along with his parents, fled to the United States and resided in Denver, Colorado, after the Secret War ended in 1975; and

WHEREAS, they eventually moved to Fresno, California, where Phia worked alongside his parents who were hardworking agricultural workers, and contributed to the local agricultural business; and

WHEREAS, in 1989, he graduated from McLane High School; and

WHEREAS, driven by his willpower and passion to serve his community, Phia enrolled in the Fresno Police Academy and completed his training in 1991; and

WHEREAS, Phia was first appointed a reserve officer in 1992, and eventually was hired by the Fresno Police Department in 1993; and

WHEREAS, he was assigned to the Multi-Agency Gang Enforcement Consortium (MAGEC), Northwest District Neighborhood patrol, and then the Fresno Area Express (FAX) Unit; and

WHEREAS, Phia dedicated 26 years as a police officer to the Fresno Police Department, and was known for his humbleness and contagious humor; and

WHEREAS, Officer Phia Vang left behind his family, fellow officers, and friends on Monday, February 4, 2019, due to an incoming intoxicated driver ending his life; and
