WHEREAS, the Commission conducted a public hearing to review the Plan Amendments and considered the Planning and Development Department's report recommending approval of the Plan Amendment application; and,

WHEREAS, the Fresno City Planning Commission considered the Plan Amendments relative to the staff report and environmental assessment issued for the project; and,

WHEREAS, the Fresno City Planning Commission invited testimony with respect to the Plan Amendments; and,

WHEREAS, ___ members of the public spoke in opposition of the project and ___ members of the public spoke in favor of the project.

NOW, THEREFORE, BE IT RESOLVED that the Fresno City Planning Commission, based upon information presented at the hearing, finds in accordance with its own independent judgment that there is no substantial evidence in the record to indicate that the Plan Amendment may have a significant effect on the environment as identified by, and evaluated within, Environmental Assessment No. P20-03758, an Addendum to
