A mediation program falls far short of what is needed to reduce the thousands of evictions that happen in Fresno every year. The courthouse already has a mediation program and it has minimal impact on the likelihood of a tenant being able to stay in the home. In contrast, studies from other jurisdictions have shown that a right to counsel for tenants dramatically reduces evictions and even eviction filings, meaning landlords are less likely to file for eviction when they know that tenants have legal representation. This will reduce the large amount of illegal evictions and evictions over petty issues that the court currently processes every week. A comprehensive right to counsel, as proposed by the Fresno Right to Counsel Coalition, is more proactive and evidence-driven. It will reduce evictions and homelessness and also prevent families from the costs and trauma of being displaced from their homes. It will also balance the courtroom, where 73% of landlords have attorneys compared to only 1% of tenants. I strongly oppose the mediation proposal and urge City Council to listen to the community and support the RTC Coalition's proposal for eviction diversion and guaranteed legal representation for tenants instead. The city has the funds to implement it.. This is a critical opportunity as we have more federal relief to support housing stability than we have ever had before. We cannot afford to miss this opportunity.

Fresno is a city where 50% of the occupants are renters; the majority of tenants pay over 30% of their income on rent and utilities, and although the cost of living has been rising for decades, incomes remain flat. To make matters worse, Fresno County suffers an affordable housing shortage of 35,000 units. This is a recipe for housing instability and displacement due to eviction, which the RMP does nothing to mitigate. The Fresno Right To Council Coalition has submitted a comprehensive Right To Council Proposal (RTC), which is based on programs implemented in major cities around the country. The RTC provides preventative and real time interventions proven to reduce evictions and housing displacement: 1)Education On Tenent/Landlord Rights; 2)Rental Assistance For Eviction Avoidance; 3)Partnering With Community Programs For At Risk Renters; 4)Legal Council And Representation For Those Facing Eviction, and more. The City Council proposed RMP would provide two law clerks to service their entire program. I submit this comment in my personal capacity as a resident of District 1. I am an attorney specializing in multiple aspects of affordable housing. Prior to my current job, I worked as an eviction defense attorney in Fresno. I strongly oppose the Rental Mediation Program. It is a flawed half measure that will not protect most residents from evictions. A few flaws:

1. Most residents do not seek help until a UD is already filed. A resident has 5 court dates to file an answer. If a resident fails to file an answer timely, the resident will get a default judgment and eviction without trial. This is how most evictions occur. Trial must be set within 21 days. This program does not stay the 5 day deadline and will result in default judgments. In this way it can actually HARM residents.

2. A clerk cannot fully evaluate the legality of the eviction if the eviction has not been filed. You can't evaluate a lawsuit that doesn't exist yet.

3. This does not change the power imbalance in court between tenants, without lawyers, and landlords, who have lawyers.

4. Most residents will not know how to utilize or access this program. Poor individuals without internet access, seniors without internet literacy, farmworkers, and other vulnerable people who do not have access to reliable internet will not be served.

Public Comment RE: ID 21-504 Opposition to Rental Mediation Program

Dear Council President Chavez and fellow Councilmembers,

We are taking this opportunity to submit comments in **opposition** to Item 21-504 regarding the Rental Mediation Program sponsored by Council President Chavez. Leadership Counsel for Justice and Accountability, Faith in the Valley, Fresno Building Healthy Communities, and Root and Rebound work alongside the most impacted communities in the City of Fresno. We're working to advance a movement for racial justice and health equity, and prioritize people over profit for a future where everyone is treated as sacred, and has a chance to thrive and live a healthy decent life.

The Rental Mediation Program being introduced is a program that is deeply flawed and falls far too short of actually addressing Fresno's eviction crisis. For almost a year now, Faith in the Valley along with Leadership Counsel have been researching, advocating, and pushing for a comprehensive <u>Eviction Diversion and Homelesness Prevention Program</u>. Our coalition developed this research-driven, comprehensive, community-led proposal that includes: (1) a city-wide tenant and landlord outreach and education campaign; (2) legal assistance, which includes mediation to help renters and landlords find a fair resolution; (3) coordinated assistance between other vital city services (i.e. Code Enforcement, Anti-Slum Enforcement Team, Housing Retention Program, etc.); and, if needed, (4) direct legal representation as a last resort.

Our proposal comes from residents who are directly impacted by the power imbalances and injustices in our housing and legal systems. People directly impacted by the housing crisis and a legacy of housing injustice are the experts who can lead us toward a model of housing where everyone has a safe, accessible and permanently affordable place to call home. We must invest in a court of action to stabilize homes before they become homeless, especially during an





unprecedented public health crisis. Evictions during a global pandemic put tenants' health and safety, and the wider community, in even greater harm. **Investing in access to legal aid for tenants proves to be cost-effective and saves the city and its constituents more money in the long run.**

The Rental Mediation Program being introduced lacks empirical research and any understanding of the needs of Fresno tenants and residents. There seems to be no community involvement, no comprehensive solutions to the issues, and no meaningful research done. This program proposal puts a barrier between those whose housing issue may not be deemed as illegal but could be avoided. Tenants need to know their rights, legal assistance, and a right to counsel to avoid being evicted, that destabilizes households and children as they bear the burden of not having stable secure housing.

This is a civil rights issue. About half of Fresno residents are renters. Renters are disproportionately Black, Indigenous, or People of Color, and frequently low-income. Not surprisingly, there are huge disparities in legal representation in Fresno's housing court. Our <u>analysis of eviction court records</u> in Fresno revealed that less than 1% of renters have legal representation compared to 73% of landlords and a recent study by the Eviction Lab revealed <u>racial and gender disparities in evictions</u>.

Tenants and landlords need an educational portion to understand their rights and duties. Tenants need legal assistance to navigate complicated court documents and deadlines. Tenants need someone to be on their side when all other options fail. Fresnans need an Eviction Diversion and Homeless Prevention Program that will be **open and available to all**. The Rental Mediation Program does none of these things and has no guidance or direction on how eviction and the consequences that follow will be avoided or mitigated. The Rental Mediation Program would be a disservice to tenants, landlords and advocates who have faced housing issues throughout the entire pandemic with no relief or assistance.

We urge the City Council to oppose the proposed Rental Mediation Program. After nearly a year since the City Council supported the concept of a right to counsel program, the council should adopt and implement the community-driven <u>Eviction Diversion and Homelessness Prevention</u> <u>Program</u>. We have done the work, the research, and the outreach. Now it's time to implement.
