RECITALS

WHEREAS, the City and the Consultant entered into an agreement on October 18, 2018, (Agreement) to provide professional engineering services for the preparation of plans and specifications for the construction of a Solid Waste Convenience Center (Project) for a total fee of \$49,700; and

WHEREAS, City and Consultant entered into the First Amendment to Agreement on June 8, 2020, to extend the original Agreement to December 31, 2021; and

WHEREAS, the parties have negotiated an increase of \$8,000 in CONSULTANT'S compensation to add to the Bidding Phase scope of services for the additional tasks in rebidding the Project;

WHEREAS, with entry into this Amendment, the Consultant agrees it has no claim, demand, or dispute against the City.

AGREEMENT

NOW, THEREFORE, the parties agree that the aforesaid Agreement be amended as follows:

1. Subsection (a) of Section 3 Compensation of the Agreement is amended in its entirety to read as follows:

"CONSULTANT's sole compensation for satisfactory performance of all services required or rendered for the Project pursuant to this Amendment shall be a total fee not to exceed Fifty-Seven Thousand Seven Hundred (\$57,700), paid on a time and materials basis in accordance with the scheduled fees contained in **Exhibit A**."

2. Except as otherwise provided herein, the Agreement entered into by City and Consultant, dated October 18, 2018, remain in full force and effect.
