# F. GENERAL ADMINISTRATION

1) Workshop on Housing Element Amendment – ID17-541

Sophia Pagoulatos, Development and Resource Management Department Planning Manager, presented the Housing Element Workshop and the City's Housing Element Amendment. Spanish and Hmong translators announced that they were available if needed.

Ms. Pagoulatos reviewed the Housing Element Amendment, a part of the General Plan that requires certification by the California State Department of Housing and Community Development. Although the Housing Element content has not changed since last presented to the HCDC, the City received additional public comments during the 30 day public review period. Of the 68 total comments, 11 were beyond the scope of the Housing Element but were forwarded to appropriate agencies. The remaining 57 comments are listed in the Housing Element matrix specifically for public comments and are reflected in revisions to the Housing Element in chapters 1, 3, and 6. The City also received an additional comment letter after the comment period ended; the comments included in that letter are also reflected in the matrix.

Commissioner Hardie recommended sending an announcement to developers and contractors that are licensed in the city of Fresno, communicating where to find the Housing Element on the City's website.

Ms. Pagoulatos concluded her presentation and announced that the Housing Element Amendment is scheduled for City Council consideration, April 13, 2017.

2) ID17-537 Actions Pertaining to the Fiscal year 2017-2018 Emergency Solutions Grant ESG and Housing Opportunities for Persons with AIDS, HIV HOPWA Programs. Staff is recommending that the City Council adopt the ESG/HOPWA evaluation panel's ranking and funding.

Kelli Furtado, Development and Resource Management Department Assistant Director reviewed the actions pertaining to the item. She stated that the HCDC is being asked to consider the scores and recommendations of the ESG/HOPWA ranking panel, and make a recommendation to the City Council.

Dan Casey, Project Manager, and Thomas Morgan, Housing Manager, presented the item.
