F-1 ID17-1140 Workshop pertaining to the City of Fresno's Program Year 2016 Consolidated Annual Performance and Evaluation Report (CAPER):

Tom Morgan, DARM Housing and Community Development Divison
Manager introduced staff members Corrina Nunez, Todd Stermer, Erica
Castaneda and Dannye Casey. Mr. Morgan presented an overview and
PowerPoint related to the 2016-2017 CAPER by reviewing the performance
as it relates to the four goals identified in the City's 2015-2019 Consolidated
Plan. Those goals include 1) Safe and Affordable Housing, 2) Homeless
Services, 3) Community Services, and 4) Public Facilities and Public
Improvements. A Public Review Draft of the CAPER was made available on
September 1, 2017. The public comment period is through September 18,
2017. The City will consider all public comments through the public hearing
scheduled for September 21, 2017 at a regularly scheduled and properly
noticed City Council meeting. Any public comment received at the HCDC
meeting will be summarized and read into the record at Council for
consideration.

H-1 <u>ID17-1260</u> Discussion of Protocol for Utilizing Interpretation Services.

Ms. Furtado reviewed the procedures and costs associated with providing translation services at all HCDC meetings and compared the HCDC process with the City Council process. Discussion among Commissioners resulted in City staff receiving direction on future utilization of translators for HCDC meetings. For consistency, staff was directed to continue providing information to the public on how to request translation services in advance of HCDC meetings and to continue coordinating translation services through the City Clerk's Office by request. In addition, HCDC Commissioners stated

that translators will also be coordinated for HCDC meetings that include a public hearing.

H-2 <u>ID17-1259</u> Commission to vote on a new Chairperson and Vice Chairperson for FY2018.
