*Councilmember Chavez spoke regarding Prop 36 and the folks who were trying to get help with their substance abuse problems, individuals who have mental health problems and those who are not ready to get out of homelessness. Chavez asked Preston Prince to speak about the amount of money that is spent on reducing homelessness in Fresno. Councilmember Chavez also mentioned the lack of resources the City of Fresno has to support the homeless.*

*Councilmember Chavez motioned to amend the ordinance to include; in lieu of being taken to jail and paying a \$1,000 fine, at the election of the citing police officer and with the consent of the individual, be taken to a facility providing social services related to mental health, housing, and or substance abuse treatment. Furthermore, as an alternative to a fine or jail sentence, the City would encourage the Court to grant diversion or probation with a condition the offender complete a rehabilitation program. Councilmember Brandau accepted the amendment.*

*Councilmember Caprioglio spoke regarding homeless veterans and asked Chief Dyer to speak about the services that are provided to them.*

*Vice President Soria asked Chief Dyer how Fresno Police Department handles enforcement of the homeless individuals and the impact of addressing other crimes that might be of a higher priority. Soria also address the shortage of resources, money and help from the County of Fresno.*

*Mayor Brand spoke regarding the 10 year plan of prior Administration and the amount of money spent by other Cities in California to help the homeless. Mayor also spoke about affordable housing and Faith Leaders on Homelessness. He further spoke about the Housing Authority and the need to work with the County of Fresno who provides all public health and behavioral health services.*

*Shawn Jenkins, West Care spoke regarding affordable housing, the need for additional resources and the progress in getting the Veterans off the street.*

*Council President Olivier asked staff to report to the Council and City Manager as to the progress that is being made and what happens to those who have vouchers and are waiting for housing.*

*Council directed staff to bring back a Resolution establishing a data report and to be brought back to Council for approval at a latter date.*
