pedestrians in that area. They explained the movement of the
McKinley and Blackstone going under the railroad tracks along
with utilities and telecommunications lines. The construction is
expected to take about 2.5 years.

## 9. Subcommittee Reports

#### a. Transportation

Carolina Illic is the Planning Manager for FAX and announced upcoming workshops on proposed mew service routes that would service the downtown transit center at Courthouse Park to Amazon and Ulta. In-person workshops are August 11 and 20, and the virtual workshop is August 17.
