RESOLUTION - Of Intention to annex Final Tract Map No. 6103, Annexation No. 62, to the City of Fresno Community Facilities District No. 11 (parcels bounded by E. Fancher Creek Drive, S. Purdue Avenue, S. Bundy Avenue, and E. Beck Avenue) (Council District 5)

RECOMMENDATION

Adopt Resolution of Intention to annex Final Tract Map No. 6103 to City of Fresno Community Facilities District No. 11 ("CFD No. 11").

EXECUTIVE SUMMARY

File #: ID#15-690, Version: 1

The landowner has petitioned the City of Fresno to have Final Tract Map No. 6103 annexed to CFD No. 11 to provide funding separately for the operation and reserves for maintenance ("Services") pertaining to the paved alley and alley lights as associated with this subdivision. The cost for the Services for these improvements is \$53.34/lot annually (totaling \$1,600). Final Tract Map No. 6103 shall share in the costs for Services for both Annexation No. 62 and Annexation No. 14 and is located entirely in the Fresno City Limits. The Resolution of Intention begins the process, sets the required public hearing for Thursday, September 24, 2015, at 10:00 a.m., and defines the steps required to complete the annexation. (See attached location and feature maps.)

BACKGROUND

On November 15, 2005, the Council of the City of Fresno adopted Resolution No. 2005-490 forming CFD No. 11 to fund public maintenance of landscaping, open spaces, local streets, local street lights and street furniture, curbs, gutters, sidewalks, street trees and other public facilities and services as defined by the City of Fresno Special Tax Financing Law, Chapter 8, Division 1, Article 3 of the Fresno Municipal Code ("City Law").

Final Tract Map No. 6103 is a proposed subdivision within the boundaries of existing Final Tract Map No. 5232 and Annexation No. 14 of CFD No. 11. The landowner has made a request to the City of Fresno to have Final Tract Map No. 6103 annexed to CFD No. 11 to provide funding separately for the Services pertaining to the paved alley and alley lights as associated with this subdivision. (See attached location and feature maps.)

Final Tract Map No. 6103 shall share in the costs for Services for both Annexation No. 62 and Annexation No. 14 and is located entirely in the Fresno City Limits.

The attached Resolution initiates the annexation process, sets the public hearing on this matter for Thursday, September 24, 2015, at 10:00 a.m., sets the Maximum Special Tax at \$53.34 annually per residential lot (totaling \$1,600) for FY15-16 and sets the annual adjustment of the Special Tax at +3% plus the increase, if any, in the construction cost index for the San Francisco Region.

Annexations to existing community facilities districts are permitted under City Law. The legislative body must follow certain prescribed procedures as outlined below:

- Adoption of a Resolution of Intention to Annex to CFD No. 11
- Required 7-day minimum Notice of Public Hearing
- Public hearing on Annexation and Levy of Special Tax
- Call a Special Mailed-Ballot Election on the proposed Special Tax
- Declare the Results of the Election
- Formal Adoption of Special Tax Levy (if election passes)

The attached Resolution has been approved as to form by the City Attorney's Office.

ENVIRONMENTAL FINDINGS

By the definition provided in the California Environmental Quality Act Guidelines Section 15378 this item does not qualify as a "project" and is therefore exempt from the California Environmental Quality Act requirements.
