- Advocacy for issues pertaining to individuals with disabilities
- Volunteerism that has a positive impact on individuals with disabilities
- Development of new programs or services impacting individuals with disabilities
- Customer service to individuals with disabilities that is above and beyond the standard
- Innovation or Entrepreneurship by an individual with a disability or that has a positive impact on individuals with disabilities

Selection process

The nomination period will be open from June 1, 2016 through August 1, 2016. Current Commissioners are not eligible to nominate or be nominated for achievement awards however in the case that no nominations are received for a particular category the DAC may select award recipients at their discretion. The DAC will designate a task force to review submissions and select the top two nominees for each category. At the September regular DAC meeting commissioners will vote from the top nominees for the award recipients. Recipients will be honored in October, coinciding with Disability Awareness Month.
