- VIII-A** [ID 25-1064](#) Announcement of Launch of the Draft Tower District Specific Plan, Draft Tower District Design Standards and Guidelines, and EIR for Public Comment

*Winch from WRT, gave a presentation about the structure of the Tower District Specific Plan, Tower District Design Standards and Guidelines, and the Environmental Impact Report.*

*Johnson commented about the EIR, acknowledging the Tower District's lack of park space affecting the community's health. Although park development like Trolley and Broadway show utilization of infill opportunity the Tower's already built out urban form prevents major park development.*

*Atkinson, responded to Johnson's comment about infill development and shared the City of Fresno's ADU program and announced free standard plans for duplexes. Developers can combine the standard plans of the duplexes and ADUs to create cottage courts for large lot developments.*

*Member of the public congratulated the committee for the work accomplished. Expressed focus upon infill opportunity and pocket park developments like Trolley Park.*
